2008-2009 SCHOLARSHIP INSTRUCTIONS UCSB ACCOUNTING STUDENTS

You are invited to participate in the CPA/Law Society's scholarship selection process for 2008-2009. The CPA/Law Society anticipates awarding five \$3,000 scholarships to accounting students from UCSB. This competition is open to Junior or Senior Level accounting students who have been accepted for the 2008-2009 academic year, who have a cumulative grade point average of 3.2 or better in all undergraduate college work. The scholarship committee will consider a number of non-GPA factors, including financial need, community service, and time spent working while enrolled in school.

The deadline is 5:00 p.m. on October 17, 2008. After reviewing all applications, the scholarship committee will contact scholarship finalists for a brief personal interview in Ventura. A PERSONAL ESSAY: (ONE PAGE ONLY)

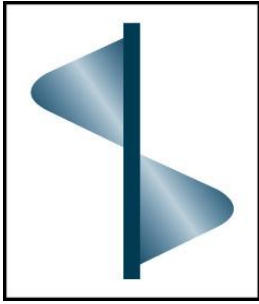
The following sample outline may be helpful. Only typewritten essays will be accepted.

- Describe who you are.
 - Why have you chosen Business as your field of study? Accounting?
 - What are your strengths? Have you overcome hurdles to be here? Goals?
- Describe your involvements and activities.
 - How were you involved? Why was the activity important?
 - Do you work full or part-time while in school?
- Discuss your leadership and community service experience.
 - Where were you involved?
 - What role did you play in that activity?
